## 2. IT Service Catalog – Web Demo

- Focus on services not organizational structure
- Approach was **who** is the customer, and **what** do they need to know
- Phase 1 Menu of Services consumer info how to order a service and price (if any)
- Phase 2 **Cost** of Services investor info what U gets, for what U pays (value proposition)
- Workgroup developed a template to promote standardization of entries format and content
- 3-4 weeks away from going public probably Feb 20
- 180 Services total 150 public 30 internal

Lander suggests a 'recent changes' feature. Sedesse will look into it.

Cromer suggests restricting access (to at least some items) due to security concerns. Lander suggests that this catalog should contain only public-safe info. Any sensitive info should be secured somewhere behind the "for more information" link.

Kirmse suggests going through it with 'fresh eyes,' from the perspective of end-users. What sort of titles/key-words would be meaningful/useful to them? Consider grouping related services by function, such as – "Services you need to establish a web-site."

Also rename some individual items with more descriptive info, so that they make better sense in the A-Z listing. Names that make sense in the context of a category become ambiguous or obscure in the straight A-Z list.

Clarify scope of the "Search" function. Perhaps have a select-dropdown ("This Site," "UF IT," "All UF").

"Faculty and Staff Services" is way too general. Need something more detailed or explanatory.

Cromer suggests links to various Unit services pages (IFAS IT, CLAS IT, etc.). Lander responds it would be better to include all the services in same catalog/application, and just show the ones appropriate to the user.

Frey suggests having a way to look at the data by providing unit – it can be helpful to understand organizational issues. Tim responds that might be yet another way to categorize and index all these services.

Curry suggests the Shib database might be useful input, because it also contains info about services.

Matusz: How will costing appear? Tim: Need to distinguish between Cost and Price. Price (if any) does belong here. Costs will be on a separate site and therefore won't appear here.

#### 3. Mainframe Disaster Recovery – Project proposal John Bevis

A confluence of events finally make this possible: ECDC, purchase of a new mainframe (and subsequent availability of old storage), and IBM's new offering for a 'Capacity Back-Up' (CBU) platform & pricing.

Cromer: Do we have a reasonable expectation re how long the mainframe will be required? If 3 years+ then the \$200K is probably well spent. Blakeslee observes from Enterprise Systems perspective, moving the Student Records System from mainframe to PeopleSoft would take at least 3 years. And that project has not yet started.

Tim talked about the Project Proposal/Charter template that was used as the basis for this proposal, and solicited feedback. All committee members agreed that this is a good format.

- Fax Server (currently in 'pilot')
  - Outbound is pretty easy; inbound much more complex.
  - Still working with IFAS & CLAS in pilot/beta.
  - Migrating VoIP fax lines will be easy; analog fax harder.
  - Target Date March 1.
